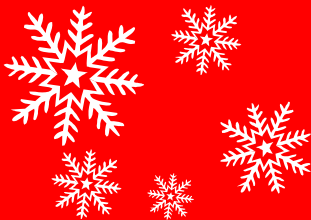

CQC (Care Quality Commission)

Birchwood were one of the first practices to be visited in East Surrey by the CQC inspectors. This inspection takes place with little prior notice to check that all surgery procedures are meeting essential standards (ie clinical care and hygiene). The CQC inspectors spent a day at the surgery looking at all procedures, talking to staff, patient group representatives and interviewing patients in the waiting room. I am delighted to announce that we have met all standards without conditions. "THE NHS BELONGS TO THE PEOPLE"

This was the subject of an educational event held at Methodist Church on November 20th and which was organised by the Birchwood Medical Practice and the Birchwood Patients Support Group.

The event started with a brief introduction by Dr. Vijaykumar, the Senior Partner of the practice, and the first speaker was Carol Rowley representing the East Surrey Commissioning Group. Carol outlined how the ESCG works together with local patients and the community.

Joe Gilligan, Chairman of the local NHS Trust then explained the value for money concept that Patients expect bearing in mind that it is Taxpayers money that is being spent. He outlined how care is provided to the local community via the Clinical Commissioning Group (CCG) especially as people are getting older.

Dr. Bosch then discussed the priorities of the GP and the associated cost of the various treatments emphasising the importance of using the right service at the right time.

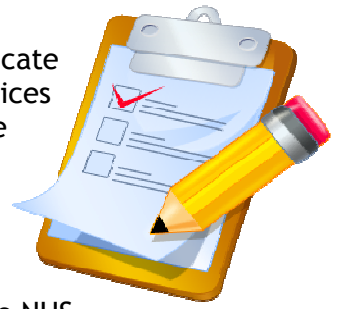
The Audience was invited to ask questions and after a fairly lively session the event was brought to a successful conclusion with thanks to all the speakers.

PATIENT SURVEY

Among the current commitments for GP practices there is a requirement to communicate with patients and ensure that their reasonable expectations for primary medical services are being met. One method of achieving this is to carry out Patient Surveys and these can be done in various ways although the Care Quality Commission expect that the method used must produce valid and meaningful results.



At Birchwood the last survey carried out used a professional survey, GPAQ Version 3 which was developed at the university of Cambridge and marketed by Patient Dynamics, a research company specialising in patient experience and approved by the NHS.

When the Birchwood Patients Support Group (PSG) studied the results of the GPAQ survey it was felt that it was not sufficiently relevant to Birchwood's particular services and procedures. It therefore failed to give patients a real opportunity to adequately indicate their opinions and consequently the results failed to give the PSG and GPs an accurate indication of where changes or improvements were needed.

It was agreed that the PSG would take on the responsibility for designing and carrying out the next patient Survey and this was done during October using the high attendance at the Flu vaccination sessions to issue the questionnaires. The response from patients was very good and 351 completed questionnaires were handed in. These have been analysed and a report is being prepared which will be discussed with the practice GPs, and action where appropriate will be planned. The final report will be posted on the Birchwood website.
